Hazardous Condition Policy

We at EcoElsa strive to provide safe, educational opportunities for adults and children. To do this, we make extensive use of Minnesota's natural outdoor public spaces. These public spaces may contain hazards unknown to us and created by conditions beyond our control, including, but not limited to, outdoor weather conditions and other visitors. While our staff will always act to avoid or take any necessary precautions against known hazards, we ask that you work cooperatively with us to identify and avoid any unknown hazards you may encounter.

Please note that our staff have only limited medical training, are not medical professionals, and do not recommend any individual participate in EcoElsa's outdoor programs if that individual has a medical condition or impairment, including but not limited to the use of prescription medications, that might affect the individual's ability to fully participate in these programs. By signing this waiver, you, the participant or legal guardian of the participant, agree that you do not have any medical conditions or impairments that might affect your ability to participate in EcoElsa's programs and that in the event of an emergency, you give permission for EcoElsa staff to administer first aid and obtain emergency medical treatment for the participant and hereby release EcoElsa and its staff from any liability related thereof.

Minor Policy

If a participant is a minor, they will not be permitted to leave with any individual except the individual designated on the program check-in sheet. EcoElsa reserves its right to charge a late fee for any failure to timely pick up a minor.

If my child requires supervision beyond EcoElsa's child to staff ratio, I understand and acknowledge that I may need to provide a personal aide at my own expense.

On my behalf, and on behalf of my children, I hereby release, covenant not to sue, discharge, and hold harmless EcoElsa llc, its employees, agents, representatives and partnering organizations, of and from the Claims, including all liabilities, claims, actions, damages, costs or expenses of any kind arising out of or relating thereto. I understand and agree that this release includes any Claims based on the actions, omissions, or negligence of EcoElsa, its employees, agents, representatives, and partnering organizations, whether a COVID-19 infection occurs before, during, or after participation in any program.
